\*For 2024 reclassification, the Idaho Department of Education will use equipercentile equating to relate student scale scores from the WIDA Alternate ACCESS form to the previous form. This will establish a student’s Alt. Proficiency level (A1, A2, A3, P1, P2, P3). A composite overall English proficiency level (PL) of P2 will reclassify students from a district’s language instruction program. Linked PLs and scale scores for reclassification will be viewable in ELMS in mid-August.

\*\*During summer 2024, a standard setting event will establish new WIDA Alt. ACCESS Achievement Standards for 2025 reclassification. New WIDA Alternate ACCESS scale scores and PLs will be posted within ELMS by the end of November 2024.

Definitions	Activities

Assessment Administration Window	The Department's designated period during which state assessments or evaluations are conducted, managed, and overseen at the LEA.
Report Available to LEAs (Vendor Platform)	The variety or range of reports that are accessible or obtainable within a system, platform, or organization, indicating the different types of data analyses, summaries, or presentations that users can access or generate.
Final Data Files Available to the State	The final student data files are available to the State. Some assessments have a longer processing period due to scoring procedures (i.e. hand scoring) and complexity, as well as test invalidations and irregularities.
Data Validation and EDUID Match	The LEA or State process of ensuring that data is accurate, complete, and consistent by verifying and validating it against predefined rules or criteria. The State matches the vendor provided assessment results to the LEA provided enrollment data. The State follows up with LEAs in case of mismatches.
Participation Rate Appeals	The formal process through which LEAs can contest the determined participation rate, to seek adjustments based on specific needs or circumstances.
Data Finalization and Release Prep	The State finalizes the appeals, aggregates, redacts, and analyzes the data. The State prepares a data file for public release, including accessibility, data notes, and press releases.
