I-A Improving Basic Programs General Overview



- Title I-A (ESEA Section 1001) The purpose of this grant is to provide all children significant opportunity to receive a fair, equitable, and high-quality education, and to close educational achievement gaps.
- I-A is a Federal program that helps students who are most at risk of meeting state academic standards and to improve proficiency on state assessments.
- This program provides funding to districts and schools that can be used for professional development, extended-time programs, and other strategies to help raise achievement levels.
- I-A laws hold states, districts/LEA, and schools accountable for improving the academic achievement of *all* students.

The *How* of Funding...



- Federal funds are currently allocated through four statutory formulas that are based primarily on census poverty estimates and the cost of education in each state:
- Basic Grants
- Concentration Grants
- Targeted Grants
- Education Finance Incentive Grants (EFIG)

Title I-A Federal Funding



- The SDE receives pre-determined grant amounts.
- The grant amounts are based on census poverty estimates that lag two years behind.
- Census poverty estimates are based on numerous variables such as aggregated tax data, SNAP benefit data, state/county poverty universal data.
- The SDE transfers funding related to charter school students from the sending school district listed on the USED tables to the appropriate charter school.

Improving Basic Programs U.S. Dept. of Education

- Funds are provided to supplement State and local efforts and may be used in any manner an LEA wishes.
- LEAs must use Title I-A funds to pay for supplemental education services to enable more students to meet challenging State standards.
- Funds are to be used to create opportunities which extend learning time, minimize pullout programs that remove children from the classroom, support instructional programs of advanced rather than memorization skills, implement accelerated curriculum strategies rather than remedial drill and practice, and those which use an evidence-based approach.

Targeted Assistance, or Schoolwide...



 ...some times that is the question. What are the advantages for students?



Title I-A Targeted Assistance Model



- Students must be prioritized by greatest need, and those most at risk for failure must be served first.
- Students identified for supplemental intervention in a targeted assistance program must be determined based on multiple education objective criteria.
- Eligibility:
 - A child you is homeless and attending ANY school in the LEA is eligible for Title I-A services.
 - Any child who has been in a Neglected or Delinquent institution or facility is automatically eligible for Title I-A services.
 - Any child who has received services in a Migrant Education program in the last two years automatically qualifies for Title I-A services.

Title I-A Schoolwide Program Model



- Schools that have a high percentage of low-income students can operate "Schoolwide Programs", in which Title I-A funds can be used to benefit the education program for the school's entire population.
- Schoolwide reform strategies incorporated in the over-all instructional program:
 - Are based on a comprehensive needs assessment
 - Address the needs of all students in school, particularly the needs of those children who are failing, or are at-risk of failing to meet the challenging State academic standards
 - Use methods and instructional strategies that strengthen the academic program in the school, increase the amount and quality of learning time, and help provide an enriched and accelerated curriculum

Schoolwide continued



- A one year planning period is recommended to move from targeted assistance to a schoolwide program. Waivers are required for schools below 40% low-income in order to implement a schoolwide program.
- Schoolwide programs must have a Schoolwide/Improvement Plan (SWIP) approved by the LEA and acknowledged by the SDE before operating as such.

Title I-A Comparability



- Demonstrating comparability is a prerequisite for receiving Title I-A funds.
- LEAs will compare like-buildings with likebuildings, based on grade span and enrollment.
- If you only have one school, or one school per grade span, you will not need to complete comparability.

Title I-A Supplement Not Supplant



- Federal funds to support low-income students must be *in addition to state* funding, not replace state and local funding.
- LEAs must demonstrate that the methodology used to allocate state and local funds to each school receiving Title I-A funds ensures that each school receives all of the state and local funds it would otherwise receive if it were not receiving Title I-A funds.

SNS Methodology Example #1



Allocation of State and Local Funds Based on Student Characteristics:

Category	Calculation	Result
Allocation per student	400 students x \$7,000	\$2,800,000
Allocation per student from low- income family	200 students from low- income families x \$250	\$50,000
Allocation per English learner	100 English learners x \$500	\$50,000
Allocation per student with a disability	50 children with a disability x \$1,500	\$75,000
Allocation per preschool student	20 preschool students x \$8,500	\$170,000
Total		\$3,145,000

SNS Methodology Example #2



Allocation of State and Local Funds Based on Staffing and Supplies

Category	Calculation	Result
1 principal	1 principal x \$120,000	\$120,000
1 librarian	1 librarian x \$65,000	\$65,000
2 guidance counselors	2 guidance counselors x \$65,000	\$130,000
20 teachers	20 teachers x \$65,000	\$1,300,000
Materials and supplies	400 students x \$825	\$330,000
Total		\$1,945,000

SNS Definitions



- Neutral: LEAs must demonstrate that the process or logic used to allocate its general state and local funds to each school ensures that each school receives all of the general state and local funds it would otherwise receive if it was not receiving Title I-A funds.
- Methodology: logic, way, process. It must be in writing.
- Title I-A *like* programs: programs that serve the purpose of Title I-A (i.e. intervention, remediation).

SNS Allowability



Not all costs are allowable!

- Not supplanting does not mean allowable
- Cost must be allowable under Title I-A
- Costs must be included in the CSFGA
- Costs must be necessary, reasonable, allocable

SNS Knowledge Check
