## Advisory Panel Functions - 20 USC §1412(a)(21)(D) and 34 CFR §300

- 1. Advise the State educational agency of unmet needs within the State in the education of children with disabilities;
- Comment publicly on any rules or regulations proposed by the State regarding the education of children with disabilities;
- 3. Advise the State educational agency in developing evaluations and reporting on data to the Secretary under Section 1418 of this title;
- 4. Advise the State educational agency in developing corrective action plans to address findings identified in Federal monitoring reports under this subchapter; and
- 5. Advise the State educational agency in developing and implementing policies relating to the funding coordination of services for children with disabilities.

  (These duties can also be found within 34 CFR §300.169)

#### 34 CFR §300.164

6. Consults with the State Department of Education (SDE) if they wish to use IDEA Part B funds to supplant (meaning replace) Federal, State, or local funds.

#### 34 CFR §300.513(d) and 34 CFR §300.514(c)

7. Reviews findings from hearings and appeals on the provision of Free Appropriate Public Education (FAPE).

### 34 CFR §300.647(b)

- Advises on the issue of disproportionality representation in special education and setting risk ratios.
- 9. Advise the State Department of Education (SDE) on the education of students with disabilities who have been convicted as adults and incarcerated in adult prisons; and
- 10. Advise the State Department of Education (SDE) on its Comprehensive System of Personnel Development (CSPD) function to aid in recruiting, preparing, and retaining qualified personnel.
