The Idaho Content Standards reflect statements of what students should know and do in various content disciplines and grades. Content standards are adopted statewide and reviewed every six (6) years by teams of educators and stakeholders. These standards provide a consistent foundational level of academic content needed to be successful at each grade level and to graduate from Idaho's public schools. Because of the age of the current science standards and the delay in adopting revised standards, many Idaho school districts have already adopted more rigorous science standards as Idaho Code requires that students meet locally established standards with state standards as a minimum. In order to meet the Constitutional requirement that the legislature establish and maintain a 'general, uniform and thorough system of public, free common schools,' this temporary rule confers a benefit by reestablishing a

The process of reassembling a teacher committee to review and make changes to the science standards proposed last legislative session took longer and was more involved than anticipated, it was not possible for the State Department of Education to meet the October deadline for proposed rules. Because some districts have already adopted the more rigorous next generation science standards, a temporary rule is necessary so that all students are learning based on more rigorous science standards. The legislature will review this temporary rule and will also review a proposed rule in the 2018 legislative session.
