

End-of-Year District Responsibilities



- IDAPA Code: 08.02.03.111.05 Requirement to communicate individual assessment results within three weeks of receiving scores (June 18, 2024)
 - Provided in a language comprehensible to the parent
 - Districts are responsible for providing reports that are accessible if a parent makes a request
- Section 3115(a)(3) of ESEA Evaluate the efficacy of the district's language assistance program(s) to ensure that ELs in each program acquire English proficiency
 - How does the district know if the LIEP is working?
 - What metrics are you using to support the program's efficacy?

Initial ACCESS for ELLs Data



WIDA Alternate ACCESS

- **2024 Reclassification Methodology**
- Idaho ESSA Plan identifies P2 (Emerging) as its reclassification criteria
 - Idaho ESSA Plan
- Delayed WIDA Alt. ACCESS Score Reports (September 13, 2024)
 - Assessment Scaling Change
 - OLD: 910–960
 - NEW: 900-980
 - WIDA Standard Setting Event (July 16-20)
 - OLD: A1, A2, A3, P1, P2 (Initiating, Exploring, Engaging, Entering, Emerging)
 - NEW: PL1, PL2, PL3, PL4, PL5 (Entering, Emerging, Developing, Expanding, Bridging)
- Reclassify WIDA Alt. ACCESS using current reclassification information
 → Employ use of a concordance table to identify related scores
 between Alt. ACCESS for ELLs to WIDA Alt. ACCESS

Kindergarten ACCESS Field Test - 2025 Administration


- District participation in KG ACCESS field test is optional

ESSA Section 1111(c)(4)(A)(ii) Establishment of Long-Term Goal

- Long Term Goal **82.71**% (Remains unchanged from 2018)
- 2023 Idaho ELs meeting growth 55.9%
 - Difference is 26.81 / 7 (years) = 3.8%






