



2025 Curricular Materials Review

Review Team Invitation

SYNOPSIS OF PROGRAM:

The Idaho State Department of Education (SDE) is requesting applications for review team members to examine curricular materials in K-12 Science, and Career and Technical Education (CTE)¹.

SCOPE OF WORK:

Review team members will examine curricular materials for both their alignment to the Idaho State Content Standards and any implementation requirements.

The SDE will provide training to the review team members via webinar and a remote review period will follow. A virtual “face-to-face” consensus meeting for review partners will culminate the review in June. Review team members will examine full curriculum in the called content area(s).

The following areas are identified as the primary responsibilities for the review team:

Responsibility	Explanation
1. Independent Webinar Training	View webinar during the weeks of March 24 – April 4, 2024
2. Material Shipments	March 30 – April 6, 2025
3. Content Specific Training Webinar	Attend April 7 – April 18, 2024 (specific dates to be announced)
4. Independent Review	Using SDE-provided evaluation rubrics, review assigned materials remotely during an eight-week open review period. Anticipate roughly a 10-20-hour time commitment per title for Science and 5-10 hours for CTE. (For K-12 teachers, reviews must be conducted while not on school

	time.) Independent review notes are required to be submitted prior to the consensus review.
5. Virtual Check-In Meetings	Attend two (2) virtual check-in meetings during the open review period (May 1 & May 30, 2025).
6. Consensus Review	Virtually attend the Consensus Review meeting June 16, 2024. Be available during Office Hours virtually June 17-20, 2024. These commitments are <u>required</u> .

COMPENSATION:

Upon completion of all requirements, reviewers will receive \$135 for each CTE course/title/program reviewed or \$270 for each Science course/title/program reviewed. Compensation is directly related to the estimated time commitment for each review type. Reviewers may receive additional compensation for remote attendance or other technology expenses. In addition, review team members also get to keep all curriculum reviewed.

MINIMUM QUALIFICATIONS:

This invitation is open to individuals who meet the following minimum criteria:

- Idaho certification
- Idaho educator with experience teaching in content area(s) specified in call

HOW TO APPLY:

Applications will be evaluated by SDE based on qualifications and need. The deadline for submission is **March 17, 2025**.
