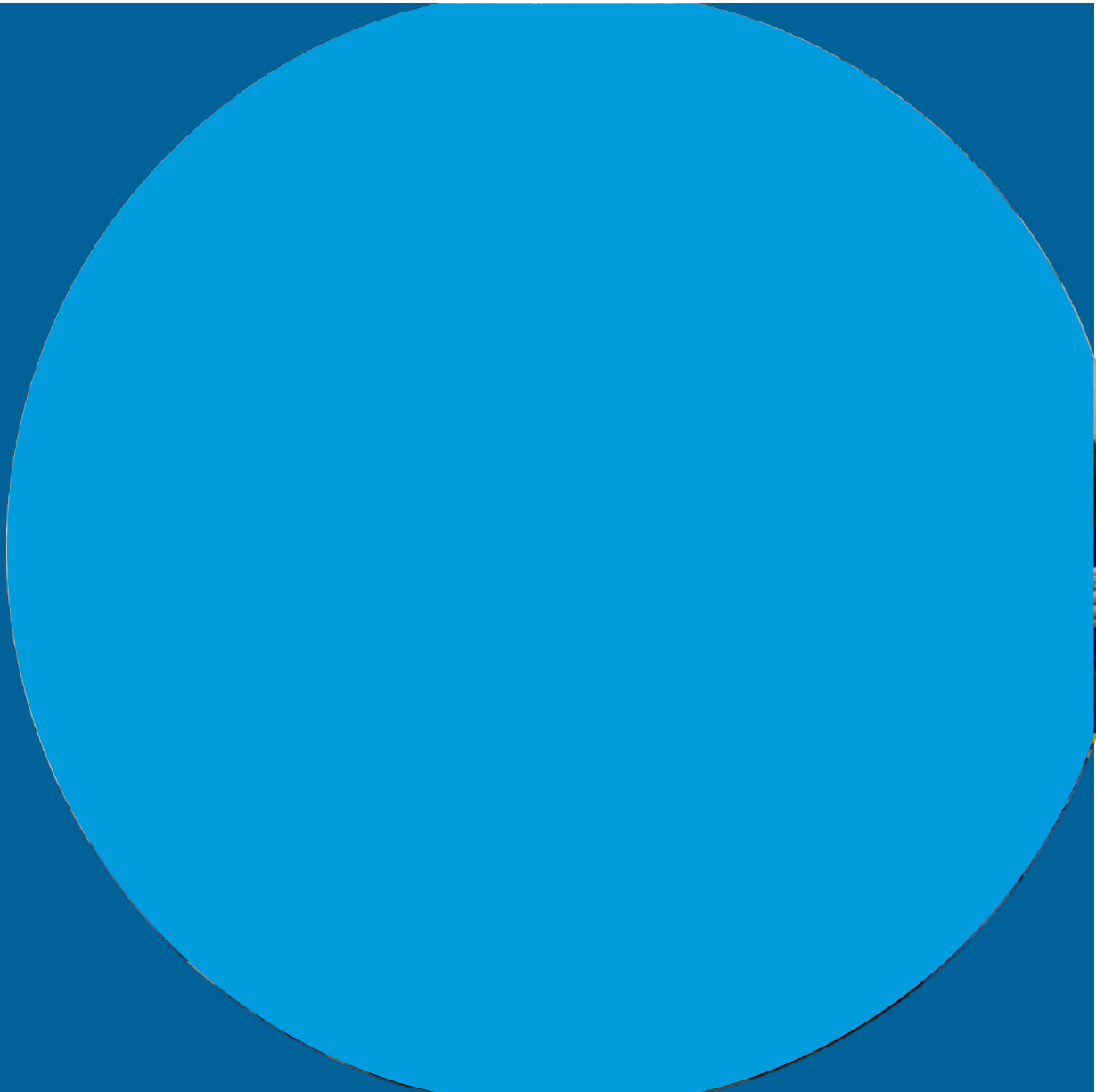

Before You Begin

You are about to begin a request for the removal of student accommodations. You will be asked to answer few questions on behalf of the student you are requesting the removal of accommodations for.

Once an accommodation is removed, it can no longer be used on any College Board.

College Board Guidelines for Removal of an Accommodation

- Do not remove an accommodation for a student registered for an upcoming test within 3 weeks from the test date.
- Do not remove an accommodation to clean a student's record in SSD Online. Instead,
 - Complete a transfer student from my school request for a student that no longer attends your school.
 - Submit a new request for an accommodation that you want to substitute.

- To update a student's demographic information, including grade or graduation date, contact the SSD Office at 844-255-7728 or +1-212-713-8333 (international), or email ssd@info.collegeboard.org for assistance.

Approved accommodations can be removed for the following reasons:

- Accommodation is no longer needed and not used in school.
- Accommodation was removed from the IEP, 504, or other formal plan.
- Student is no longer eligible for an IEP, 504, or other formal plan, and does not use the approved accommodations.
- Student and parent do not want to use the approved accommodation in any context.
- The accommodation request was submitted incorrectly.
- Accommodation was requested in error.
- Student graduated from ESL program and does not require English Learner Supports.
