FINAL ORDER

The Chief Certification Officer for the State of Idaho filed an Administrative Complaint against the educator certificate issued to Adam Foster, seeking for the Professional Standards Commission to impose discipline on Mr. Foster's certificate. *See* Idaho Code § 33-1209. Because Mr. Foster did not request a hearing within 30 days, and because Mr. Foster was determined to be in default by a hearing/presiding officer, the allegations in the Administrative Complaint are treated as admitted, Idaho Code § 33-1209(3), and are incorporated by reference as findings of fact.

Based on these findings, the Professional Standards Commission makes the following findings and conclusions:

- 1. Mr. Foster's conduct or course of conduct willfully violated a principle of the code of ethics that was adopted by the Idaho State Board of Education. Idaho Code § 33-1208(1) ("Willful violation of any professional code or standard of ethics or conduct, adopted by the state board of education."). Specifically, Mr. Foster violated Code of Ethics Principle II Idaho Admin Code r. 08.02.02.076.03 ("A professional educator maintains a professional relationship with all students, both inside and outside the physical and virtual classroom.").
- 2. Mr. Foster's conduct or course of conduct willfully violated a principle of the code of ethics that was adopted by the Idaho State Board of Education. Idaho Code § 33-1208(1) ("Willful violation of any professional code or standard of ethics or conduct, adopted by the state board of education."). Specifically, Mr. Foster violated Code of Ethics Principle V Idaho Admin

RECONSIDERATION AND JUDICIAL REVIEW

This is a final order of the Professional Standards Commission. Any party may file a motion for reconsideration of this order within 14 days of the service date of this order. The agency will dispose of the petition for reconsideration within 21 days of its receipt; if not, the petition will be denied as a matter of law. See Idaho Code § 67-5246. Petitions for reconsideration may be filed by mail addressed to the Professional Standards Commission, State Department of Education, P.O. Box 83720, Boise, ID 83720-0027, or hand delivered to the Commission at 650 West State Street, Second Floor, Boise, ID 83720.

Any party aggrieved by this final order or orders previously issued in this case may seek judicial review of the orders in this case in district court. A party may do this by filing a petition for judicial review in the district court as provided in Idaho Code §§ 67-5270 and 67-5272. The petition must be filed within 28 days of the service date of this final order; or, if a motion for reconsideration is filed, within 28 days of the service of a decision on the motion for reconsideration or denial of the motion as a matter of law. Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the agency action. Idaho Code § 67-5274.

ADMINISTRATIVE COMPLAINT

Respondent

Cina Lackey, Chief Certification Officer for the State of Idaho, alleges the following against Adam N. Foster.

GENERAL AVERMENTS

The following general averments are adopted in each count below.

- The Professional Standards Commission (Commission) regulates teacher certification in Idaho.
- 2. The Chief Certification Officer is empowered to file an administrative complaint against the certificate of a teacher or other individual certified under the authority of the Idaho State Board of Education. Idaho Code § 33-1209.
- 3. Mr. Foster holds the following certificates and endorsements issued under the authority of the Idaho State Board of Education:
 - a. Standard Instructional Certificate with Social Studies (6-12) and History (6-12)
 endorsements, Effective July 2, 2020, through August 31,2025.
 - b. Alternative Authorization Teacher to New Endorsement with Physical Education (PE) (6-12) endorsements, Effective September 1, 2023, through August 31, 2024.
- 4. Mr. Foster was employed by Ririe School District during the 2023-24 school year as a teacher.

- 5. On information and belief, the following occurred during Mr. Foster's employment.
- 6. Mr. Foster viewed pornography on an electronic device while students were in the classroom.
- 7. One student reported that she observed pornography on Mr. Foster's electronic device.
- 8. Mr. Foster spent significant time browsing social media and sports websites during class time.
 - 9. Mr. Foster submitted a letter of resignation on or about January 17, 2024.
- 10. The Professional Standards Commission may learn additional facts related to Mr. Foster's actions as it investigates circumstances related to this Administrative Complaint.

COUNT I

11. Mr. Foster's conduct or course of conduct described in paragraphs 6-9 willfully violated a principle of the code of ethics that was adopted by the Idaho State Board of education. Idaho Code § 33-1208(1) ("Willful violation of any professional code or standard of ethics or conduct, adopted by the state board of education."). Specifically, Mr. Foster violated Code of Ethics Principle II Idaho Admin Code r. 08.02.02.076.03 ("A professional educator maintains a professional relationship with all students both inside and outside the physical and virtual classroom.").

COUNT II

Mr. Foster's conduct or course of conduct described in paragraphs 6-9 willfully violated a principle of the code of ethics that was adopted by the Idaho State Board of education.

Idaho Code § 33-1208(1) ("Willful violation of any professional code or standard of ethics or conduct, adopted by the state board of education."). Specifically, Mr. Foster

violated Code of Ethics Principle V Idaho Admin Code r. 08.02.02.076.06 ("A professional educator entrusted with public funds and property honors that trust with a high level of honesty, accuracy, and responsibility.").

REQUEST FOR RELIEF

The Chief Certification Officer requests that the Commission grant the following relief, as permitted under Idaho Code §§ 33-1208 and 33-1209.

- 1. That Mr. Foster's certifications be revoked.
- 2. That if Mr. Foster requests a hearing, a hearing be conducted before a hearing panel, where the Chief Certification Officer and Mr. Foster may present evidence concerning the allegations in this Administrative Complaint, to aid the hearing panel in determining whether Mr. Foster's certificate should be disciplined and, if so, what discipline should be imposed.
- Any other relief that would be just under the circumstances.

NOTIFICATION OF PROCEDURAL RIGHTS

The Professional Standards Commission wishes to notify you of the following rights.

An administrative action has been initiated against your certificate(s). Under Idaho Code § 33-1209, if you wish to contest the allegations set forth in the administrative complaint, you must request a hearing. This request must be (1) made not more than 30 days after the date of service (mailing) of the administrative complaint, (2) in writing, and (3) addressed to the state superintendent of public instruction. If you do not request a hearing or do not comply with the requirements for requesting a hearing, the allegations in this administrative complaint will be treated as admitted under Idaho Code § 33-1209(3).

In response to this administrative complaint, you may file an answer to this administrative complaint, but you must file the answer at least 30 days prior to the day of the hearing.

You have the right to be represented by legal counsel, at your own expense, during this administrative proceeding. In addition, you are entitled to the issuance of subpoenas to compel the attendance of witnesses and the production of books, documents, and other things relevant to the proceedings.

This administrative proceeding is governed by provisions of the Idaho Code, including the Idaho Administrative Procedure Act, and by provisions of the Idaho Administrative Code, including the Idaho Rules of Administrative Procedure of the Attorney General that have been adopted by the Board of Education. You may access these laws and rules online or via the Idaho State Law Library.
