FINAL ORDER

The Chief Certification Officer for the State of Idaho filed an Administrative Complaint against the teaching certificates issued to Susan Bedke, seeking for the Professional Standards Commission to impose discipline on Ms. Bedke’s certificates. *See* Idaho Code § 33-1209. Because Ms. Bedke did not request a hearing within 30 days, and because Ms. Bedke was determined to be in default by a hearing/presiding officer, the allegations in the Administrative Complaint are treated as admitted, Idaho Code § 33-1209(3), and are incorporated by reference as findings of fact.

Based on these findings, the Professional Standards Commission concludes that Ms. Bedke willfully violated the following laws and principles of the Code of Ethics adopted by the State Board of Education. Idaho Code § 33-1208(1)(j).

The Commission specifically holds that Ms. Bedke’s conduct violated Idaho Code § 33-1208(1)(g) (“Conviction, finding of guilt, withheld judgment, or suspended sentence in this state or any other state for the delivery, manufacture or production of controlled substances or simulated controlled substances as those terms are defined in section 37-2701, Idaho Code.”).

The Commission specifically holds that Ms. Bedke’s conduct or course of conduct willfully violated a code of ethics principle, adopted by the Idaho State Board of Education. Idaho Code § 33-1208(1)(j). Specifically, Ms. Bedke violated Code of Ethics Principle II (Idaho Admin. Code r. 08.02.02.076.03) (“A professional educator maintains a professional relationship with all students, both inside and outside the physical and virtual classroom.”).

Under Idaho Code § 33-1208, the Professional Standards Commission orders that the following discipline (as marked) be imposed on Ms. Bedke's certificates:

The discipline requested by the Chief Certification Officer in her Request for Relief in the Administrative Complaint.

Other discipline

Ms. Bedke's certificates are revoked.

Ms. Bedke's certificates are permanently revoked under Idaho Code § 33-1208(2).

RECONSIDERATION AND JUDICIAL REVIEW

This is a final order of the Professional Standards Commission. Any party may file a motion for reconsideration of this order within 14 days of the service date of this order. The agency will dispose of the petition for reconsideration within 21 days of its receipt; if not, the petition will be denied as a matter of law. See Idaho Code § 67-5246. Petitions for reconsideration may be filed by mail addressed to the Professional Standards Commission, State Department of Education, P.O. Box 83720, Boise, ID 83720-0027, or hand delivered to the Commission at 650 West State Street, Second Floor, Boise, ID 83720.

Any party aggrieved by this final order or orders previously issued in this case may seek judicial review of the orders in this case in district court. A party may do this by filing a petition for judicial review in the district court as provided in Idaho Code §§ 67-5270 and 67-5272. The petition must be filed within 28 days of the service date of this final order; or, if a motion for reconsideration is filed, within 28 days of the service of a decision on the motion for reconsideration or denial of the motion as a matter of law. Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the agency action. Idaho Code § 67-5274.

ADMINISTRATIVE COMPLAINT

Lisa Colón Durham, Chief Certification Officer for the State of Idaho, alleges the following against Susan Bedke.

GENERAL AVERMENTS

1. The Professional Standards Commission (Commission) regulates teacher certification in Idaho.

2. The Chief Certification Officer is empowered to file an administrative complaint against the certificate of a teacher or other individual certified under the authority of the Idaho State Board of Education. Idaho Code § 33-1209.

3. Ms. Bedke holds the following certificates and endorsements issued under the authority of the Idaho State Board of Education:

- a. Administrator certificate with School Principal (Pre-K-12) endorsement, effective September 1, 2016, through August 31, 2021.
- b. Standard Elementary certificate with All Subjects (K-8) and Mathematics (5-9) endorsements, effective September 1, 2016, through August 31, 2021.

4. Ms. Bedke was a teacher at Cassia High School in the Cassia County School District for the 2018-2019 school year.

5. On March 7, 2019, Ms. Bedke asked a student at Cassia High School to contact his mother, who was going to Mexico the following day, to purchase controlled substances from Mexico for herself.

6. Ms. Bedke requested Hydrocodone, Vicodin and an antibiotic and gave the student \$50 for him to give to his mother to purchase the controlled substances.

7. On June 10, 2019, a Judgment of Conviction and Order of Commitment was entered based upon a guilty plea to Attempted Possession of Controlled Substance, Idaho Code § 37-2732(C)(3), in *State v. Bedke*, Case No. CR 16-19-3233, in the District Court of the Fifth Judicial District, State of Idaho, Cassia County Magistrate Division. A true and correct copy of the Judgment of Conviction and Order of Commitment is attached as Exhibit A.

Count I

8. Ms. Bedke's conduct violated Idaho Code § 33-1208(1)(g) ("Conviction, finding of guilt, withheld judgment, or suspended sentence in this state or any other state for the delivery, manufacture or production of controlled substances or simulated controlled substances as those terms are defined in section 37-2701, Idaho Code.").

Count II

9. Ms. Bedke's conduct or course of conduct willfully violated a code of ethics principle, adopted by the Idaho State Board of Education. Idaho Code § 33-1208(1)(j). Specifically, Ms. Bedke violated Code of Ethics Principle II (Idaho Admin. Code r. 08.02.02.076.03) ("A professional educator maintains a professional relationship with all students, both inside and outside the physical and virtual classroom.").


REQUEST FOR RELIEF

The Chief Certification Officer requests that the Commission grant the following relief, as permitted under Idaho Code §§ 33-1208 and 33-1209:

1. Indefinitely suspend Ms. Bedke's certificate.

2. The suspension will not be lifted until medical verification is received demonstrating that Ms. Bedke may return to work and has the ability to perform all of her duties as a teacher.
3. Ms. Bedke must take a Commission approved boundary course that may not be used for renewal purposes.
4. That if Ms. Bedke requests a hearing, a hearing be conducted before a hearing panel, where the Chief Certification Officer and Ms. Bedke may present evidence concerning the allegations in this Administrative Complaint, to aid the hearing panel in determining whether Ms. Bedke's certificates should be disciplined and, if so, what discipline should be imposed.
5. That after a hearing, the waiver of a hearing, or Ms. Bedke's failure to file an Answer to this Administrative Complaint, the hearing panel issue findings of fact and conclusions of law finding the violations of law alleged herein;
6. Any other relief that would be just under the circumstances.

NOTIFICATION OF PROCEDURAL RIGHTS

The Professional Standards Commission wishes to notify you of the following rights.

An administrative action has been initiated against your certificate(s). Under Idaho Code § 33-1209, if you wish to contest the allegations set forth in the administrative complaint, you must request a hearing. This request must be (1) made not more than 30 days after the date of service (mailing) of the administrative complaint, (2) in writing, and (3) addressed to the state superintendent of public instruction. **If you do not request a hearing or do not comply with the requirements for requesting a hearing, the allegations in this administrative complaint will be treated as admitted under Idaho Code § 33-1209(3).**

In response to this administrative complaint, you must file an answer pursuant to IDAPA rule 04.11.01.270, but you must file the answer at least 30 days prior to the day of the hearing.

You have the right to be represented by legal counsel, at your own expense, during this administrative proceeding. In addition, you are entitled to the issuance of subpoenas to compel the attendance of witnesses and the production of books, documents, and other things relevant to the proceedings.

This administrative proceeding is governed by provisions of the Idaho Code, including the Idaho Administrative Procedure Act, and by provisions of the Idaho Administrative Code, including the Idaho Rules of Administrative Procedure of the Attorney General that have been adopted by the Board of Education. You may access these laws and rules online or via the Idaho State Law Library.
