
#### Consolidated Federal and State Grant Application

If there are any revisions required, they must be completed before a grant award letter is issued and money can be accessed in the Grant Reimbursement Application (GRA).

## **CFSGA** Timeline



# Timeline: March-May



- March Free & Reduced Lunch and Enrollment numbers are reported
- April Preliminary Allocations are received by the SDE from USED
- May LEA preliminary allocations are calculated and uploaded into the CFSGA application

# Timeline: May-June



- May/June LEA fills out and submits CFSGA for initial time by June 30<sup>th</sup>
- CFSGA is then reviewed by each applicable SDE coordinator.
  - Coordinator either approves their portion of the CFSGA application as submitted or makes a comment for revision or additional information
  - After all applicable SDE coordinators review the submitted CFSGA, it is either approved or returned to the LEA for revisions or additional information

# Timeline: May-June cont.



- Once the CFSGA has been reviewed and is fully approved, then funds are loaded into the GRA for drawdown
- If the CFSGA needs revision or additional information, it is returned to the LEA. After the LEA resubmits the CFSGA, the applicable SDE coordinators re-review the plan for approval or revision.

### **CFSGA** and **GRA**



### Important Note:

Funds are not loaded into the GRA until after the CFSGA has been submitted and all programs have been fully approved.

If some programs in the CFSGA have been approved but not all of them, funds will not be loaded into the GRA until all programs have been approved by the SDE coordinators.

- November Final Allocations are received by the SDE from USED and LEA final allocations are calculated and uploaded into the CFSGA application
  - Final allocations may differ from preliminary allocations

### Timeline: November cont.



### At this time, the CFSGA application will be unsubmitted for all LEAs for revision

- Please take this time to revise your CFSGA to reflect how you are actually spending the funds for the school year as this could impact GRA drawdown requests if what is being requested in the GRA is not already approved in the CFSGA
- This also impacts monitoring
