Recognition, Identification*	Description	Frequency & Most Recent
Top Performers	Perform in top 10% of schools.	Annually, Fall 2023
Goal Makers	Reach the year's interim achievement goal.	Annually, Fall 2023
*TSI	Receive <u>Targeted Support and Improvement.</u> Perform in lowest 5% per subgroup of same-type schools.	Annually, Fall 2023
*ATSI	Receive <u>Additional Targeted Support and Improvement</u> . Perform in lowest 5% per subgroup among TSI schools.	Annually, Fall 2023
*CSI Up	Receive <u>Comprehensive Support and Improvement</u> Perform in the lowest 5% of same-type schools, OR receive ATSI all 3 prior years.	Every 3 years, Fall 2022
*CSI Grad	Did not achieve 67% graduation rate.	Every 3 years, Fall 2022

*School Identification and Support



School Identification: Federal Mandate Related to Title-1 Funding

Deliver Support Foster School Improvement

THE LAW: School identification is part of the broader accountability and transparency movement codified in the Early and Secondary Education Act (ESEA) of 1965, and a recent successor, the Every Student Succeeds Act (ESSA) of 2015. Both include Title 1 provisions, affecting resources for schools that serve low-income families.

THE SCHOOLS showing **low performance** in various categories of student achievement are identified regularly. Detailed definitions and formulae at 2023 Accountability & Reporting Business Rules.

THE GOAL: Provide support and foster improvement so all students have the instruction and resources to succeed, regardless of their income or membership in categories associated with disadvantage.

4 School Identification Categories



CSI Up, CSI Grad - Every 3 Years*

Comprehensive Support and Improvement (CSI Up)

Low-performing schools: those in the lowest 5 % of overall student performance for their school type.

Comprehensive Support and Improvement – Graduation Rate (CSI Grad)

Low-graduation-rate high schools: graduation rates below 67%.

TSI, ATSI - Every Year*

Targeted Support and Improvement (TSI) Low-performing subgroups per school: subgroups in the lowest 5% of the subgroup's performance for their school type.

Additional Targeted Support and Improvement (ATSI)

> Very low-performing subgroups per school: the lowest 5% subgroup performance among TSI-identified schools.

Comprehensive Support & Improvement



CSI Up & CSI Grad – Identified Every 3 Years*

Comprehensive Support and Improvement (CSI Up)

- Low-performing schools. Identified every 3 years.
 - Schools in the lowest 5% of overall student performance for their school type; OR
 - Schools with persistently, very-low performing subgroups (3 consecutive years ATSI).
- School types: K-8, High School, Alternative High School.
- Exit every 3 years after plans, actions, and improvements to above the lowest 5% overall and above the lowest 10% in ISAT Math and ISAT ELA.

Comprehensive Support and Improvement – Grad (CSI Grad)

- Low-graduation-rate schools. Identified every 3 years.
- High Schools and Alternative High Schools with a 3-year average graduation rate below 67%.
- Exit every 3 years after plans, actions, and improvement of graduation rate above 67% (in most recent 2 years, or averaged over 3 years).

Targeted & Additional Targeted Support & Improvement



TSI & ATSI - Identified Every Year*

Targeted Support and Improvement (TSI)

- Low-performing subgroups. Identified annually.
- Schools in the lowest 5% of any subgroup's performance for their school type.
- School types: K-8, High School, Alternative High School.
- Exit annually after plans and improvement to above the lowest 5%.

Identified for Additional Targeted Support and Improvement (ATSI)


- Very low-performing subgroups. Identified annually.
- The **lowest 5%** of any **subgroup's performance** for their school type among TSI-identified schools that year (amounts to roughly the lowest 1% in subgroup performance statewide).
- School types: K-8, High School, Alternative High School.
- Exit annually after plans and improvement to above the lowest 5% of TSI schools.

CSI Identification Process – 5 Steps



Identify Schools for Comprehensive Support and Improvement (CSI Up) in 5 Steps*

1. Calculate 3-year average of each academic & non-academic indicator per school (20 minimum scores across 3 years to continue).



2. PERCENTILE RANK schools per 3-year indicator, within school type.

3. Calculate <u>Identification</u>

Composite: Weight each indicator's percentile rank by the indicator weight (heavier weight for academic indicators). Sum the weighted indicators, per school.

4. PERCENTILE RANK

Title 1 schools'
Identification Composites
within school type. The
Composite Cut-score is at
the 5th percentile.

5. Identify all schools at or below their school type's Composite Cut-score for CSI Up*.

TSI Identification Process – 5 Steps



TSI in 5 Steps*

SAME Process as for CSI Up, Except PER SUBGROUP, per School

1. Calculate 3-year average of each academic & non-academic indicator PER SUBGROUP, per school (20 minimum scores across 3 years to continue).

2. PERCENTILE RANK schools per 3-year indicator, **PER SUBGOUP**,
within school type.

3. Calculate Identification Composite PER SUBGROUP: Weight each indicator's percentile rank by the indicator weight (heavier weight for academic indicators). Sum the weighted indicators, per subgroup, per school, within school type.

4. PERCENTILE RANK
Title 1 schools'
Composites within school type, per student subgroup. Identify
Composite Cut-scores at the 5th percentile.

5. Identify all schools at or below their school type, subgroup Composite Cut-score for TSI*.

Identify Schools for <u>Additional Targeted Support and Improvement (ATSI) in 5 Steps*</u>

SAME as TSI Process **Except USING ONLY TSI-IDENTIFIED SCHOOLS**

Recognition	Description	Frequency & Most Recent
Top Performers	DO NOT perform in top 10% of schools.	Annually
Goal Makers	DO NOT reach the year's interim achievement goal.	Annually
TSI	Make and follow an improvement plan. Perform ABOVE lowest 5% per subgroup.	Annually
ATSI	Make and follow an improvement plan. Perform ABOVE lowest 5% per subgroup.	Annually
CSI Up	Make and follow an improvement plan. Perform ABOVE lowest 5% of same-type school; Perform ABOVE 10% on ISAT.	Every 3 years
CSI Grad	Achieve 67% graduation rate 2 consecutive years or achieve average 67% graduation rate across 3 years.	Every 3 years
