


## **OSEP Fast Facts: Black or African American Children with Disabilities**

For the purposes of this fact sheet, an Black or African American<sup>1</sup> with disabilities is a child or youth, who has origins in any of the Black racial groups of Africa (does not include person of Hispanic/Latino ethnicity) and is eligible for special education and related services under the Individuals with Disabilities Education Act (IDEA), Part B. <sup>1</sup> IDEA Part B Child Count and Educational Environments for School Year 2017-2018, OSEP Data Documentation. <u>https://go.usa.gov/xd8WE</u>









In SY 2017-18, Black or African American children with disabilities, ages 14-21, exiting school were more likely to drop out and less likely to graduate with a regular high school diploma than all students with disabilities.
